SacRT Fiscal Year 2022 Budget Virtual Public Hearing

SacRT will hold a virtual public hearing on SacRT's Fiscal Year 2022 Preliminary Operating and Capital Budget. The hearing will be live streamed on YouTube on Monday, May 10, 2021, during the regularly scheduled SacRT Board of Directors Meeting. Due to COVID-19 restrictions, the public meeting and hearing is being held virtually.

The following is a list of SacRT's Proposed Program of Project and Federal Transit Administration (FTA) Allocations:

- Section 5307 Urbanized Area Program Jobs Access/Reverse Commute Operating Assistance \$1,106,565
- Congestion Mitigation and Air Quality Improvement Program \$710,000
- Coronavirus Aid, Relief, and Economic Security (CARES) Act \$28,774,873
- Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) \$37,854,695

These amounts are subject to change pending actions taken by the Board of Directors prior to the public hearing. View the preliminary budget document at sacrt.com/budget.

RydeFreeRT – Fare-free transit program for youth

Youth in grades TK through 12th can take advantage of RydeFreeRT, the fare-free transit program for youth and students. With RydeFreeRT, youth can ride the entire SacRT transit network, including SacRT buses, light rail, and SmaRT Ride on-demand microtransit service for FREE! RydeFreeRT is available all day, any day of the week during regular SacRT service hours.

Due to distribution limitations resulting from COVID-19, all a student needs to ride for free is a student ID card or a RydeFreeRT card. No sticker is required to ride. Youth who are experiencing homelessness or taking part in foster programs are also allowed to participate in the program, regardless of current residence or school address.

For students and youth who need a replacement card, do not have a student ID, or that do not have a student ID or RydeFreeRT card, they can visit SacRT's Customer Service and Sales Center located at 1225 R Street (adjacent to the 13th Street Station). For more information, visit rydefreert.com.

Morrison Creek Station Construction Continues

SacRT construction crews continue to build out the Morrison Creek light rail station. Originally planned as part of the Blue Line to Cosumnes River College light rail extension, the station was not completed with the extension project due to lack of development in the immediate area. However, with federal construction funds set to expire, station construction is underway and will open late summer as a walk on only station. Development of the surrounding area is expected to take place in the near future.

With area schools reopening, SacRT resumed the 200 series bus service on April 5, 2021, and added additional trips on April 22, 2021.

SacRT Expects Ridership Increases as State Begins to Reopen

As more businesses are reopening and people return to work and school, SacRT is expecting to see an increase in ridership on bus, light rail and SacRT GO paratransit services. With decreasing COVID-19 cases and more people getting vaccinated SacRT wants to ensure a successful transition to a return to normalcy, while safely accommodating additional riders.

Masks will continue to be required while riding transit, even if you have been vaccinated. A mask must cover your nose and mouth at all times. Keeping COVID-19 in check is critical to reducing the spread of the virus and speeding up reopening timelines.

California is planning to fully reopen by Tuesday, June 15, 2021, and if California successfully reopens, the State will be lifting nearly all COVID-19 restrictions with the exception of the mask mandate, which will continue.

The safety and health of our employees and customers has been and continues to be a top priority for SacRT and we are taking a number of proactive measures in response to COVID-19, including:

- Blocking off certain seats in buses and light rail trains to provide physical distancing
- Requiring all employees and riders to wear a mask
- Fogging and disinfecting buses, light rail trains, facilities and all touch points
- Urging riders to download ZipPass the free mobile fare app to reduce touchpoints
- Asking customers to not ride transit if they are sick

SacRT installing new smart fare vending machines on the Gold Line

SacRT is continuing to install new smart fare vending machines on the Gold Line. The new smart fare machines have been installed on the Blue and Green Lines. Expected completion for installation on the Gold Line is the end of May.

The new smart machines offer a user-friendly touch-screen interface and provide the following additional features:

- Pay with cash or debit/credit card
- Pay with Google Pay or Apple Pay
- Print single ride tickets and daily, semi-monthly, and monthly passes
- Option to add tickets or passes directly to the ZipPass mobile fare app
- QR code reader
- Audio voice option and screen prompts available in English and Spanish

SacRT is Your FREE Ride to COVID-19 Vaccine Sites

SacRT continues to offer free transit rides for everyone who needs to get to a scheduled COVID-19 vaccine appointment location through Monday, May 31, 2021. This includes all vaccination sites in Sacramento County within SacRT's service area, including hospitals, pharmacies, and other immunization locations.

To ride free, customers only need to show a COVID-19 vaccine appointment confirmation in the form of an email, text, or vaccine card, which will serve as valid fare only on the date noted on the appointment confirmation to ride SacRT's fixed-route bus, light rail, Folsom Stage Line, SmaRT Ride, Causeway Connection or SacRT GO paratransit services. When boarding a bus, show the operator either a printout or screenshot on a smartphone, or have ready to show a fare inspector when riding light rail.

Please note: SacRT is only providing transportation, not administering the COVID-19 vaccine itself.

Bike and Ride Bus and Light Rail

May is National Bike Month and SacRT makes transit bicycle friendly by providing opportunities for bicyclists to combine biking with riding SacRT. SacRT has bike racks on buses, light rail trains and at stations.

Motorized bikes are not allowed in or on SacRT vehicles and bikes cannot be more than 80 inches long and much be less than 48 inches high.

The Sacramento Area Council of Governments is holding several May is Bike Month events to get more people to experience the physical and mental health benefits of biking while staying socially distanced.

Download the Alert SacRT App: Service Alerts for specific light rail lines now available

The Alert SacRT mobile reporting app now allows users to choose to receive light rail service alerts for each specific light rail line, Blue, Gold or Green. The light rail line alert options can be found by clicking the "More" button and then click on "Service Alerts" for the specific lines.

The free app is available for download from the App Store (iOS) and Google Play (Android). The app provides light rail service alerts and offers a quick and discreet method for reporting facilities and/or nuisance concerns directly to SacRT Police Services (RTPS) using a smartphone or tablet.

Users without a smart phone can send texts directly to RTPS at 916-318-3330.

Elk Grove's transit services officially joins SacRT

SacRT and the City of Elk Grove formalized an annexation agreement that will officially bring the City of Elk Grove transit services into SacRT as a member entity effective Thursday, July 1, 2021.

SacRT has been operating e-tran and e-van services under a service contract since July 2019. Under the annexation agreement, SacRT will provide fixed-route local, commuter and paratransit services, and maintenance operations for e-tran and e-van.

As part of the agreement, SacRT is committed to a seamless transition with no impact to current riders. Service levels will be maintained or improved, and there are no short-term plans to make changes to the existing bus service or fares. e-tran and e-van employees who have been employed since the service contract in July 2019 will remain in their current position.
